

HYDE PARK SQUARE ART SHOW

The 46th Annual Hyde Park Square Art Show is accepting applications for art exhibitors to display and sell their work in one of the area’s finest juried art shows. Applicants must be prejudged in April (see exception below) and those accepted into the October show will be notified by mail.

CATEGORIES OF SHOW ENTRIES

Ceramics, Crafts, Fiber Art, Glass, Graphics, Jewelry, Mixed Mediums, Painting, Photography, Sculpture, Wood

QUALIFICATIONS FOR EXHIBITORS

All applicants will be prejudged. All work and/or materials must be the artist’s own creation and representative of the items submitted by the artist for prejudging. No pre-manufactured or commercially made items (T-shirts, sweatshirts, towels, etc.) will be permitted in the show. Each applicant may exhibit and compete in only ONE category per space, and must enter in only ONE individual’s name (no group entries).

*** EXCEPTION:** Winners and those who received honorable mention in the 2011 show are exempt from the 2012 prejudging process. They need only submit the application form and enclose the entrance fee of \$110 by **March 23, 2012** (Winners in the youth division from the previous year who are now entering the adult division ARE NOT exempt from prejudging).

PREJUDGING

To participate in the prescreening, submit the application form plus a \$30 non-refundable processing fee by **Friday March 23, 2012**. If you do not meet this **March 23rd** deadline, the entry fee for “walk-ins” on the day of prejudging will be \$50. Bring **ONLY** three (3) pieces of work in ONE category for prejudging.

NOTE: No parking in the Library lot please. Off street parking available from 8 AM until 12 Noon will be: Dr. Christine L Elfers, D.D.S. - 2758 Erie Ave. (lot is on Shaw Ave. across from the back door of the Center). Dr. Bell - 2767 Erie Ave. (lot is behind the building, entrance on Shaw Ave.). Dr. Timothy Pohlman - 2761 Erie Ave. south side of Erie Ave. (lot is behind building, entrance on Erie). Queen City Physicians- 2753 Erie Ave. south side of Erie Ave. (lot is in front and behind the building, entrance on Erie Ave.)

If you are unable to attend the prejudging, send **ONLY** three (3) images of your work for evaluation. You may send your images as JPG files on a CD, or slides. The quality of your images may influence the judge’s decisions. **Please include a 50 word maximum description of the process and materials used in creating your work.** If sending slides be sure to include a stamped #10 self-addressed envelope for their return. CD’s will not be returned to the artists. All images to be judged must be submitted prior to the March 23rd deadline. **Be sure to include your application form and the \$30 processing fee.** Slides/CD's will not be accepted the day of prejudging.

The prejudging decisions will be mailed to you the week of May 13th.

ENTRANCE FEE

All applicants accepted after prejudging must submit a one hundred (\$110) non-refundable entrance fee for space in the show. **NOTE:** Please do not send the entrance fee until after your notification of acceptance into the show, which you will receive the week of May 13th. The 2011 art show winners and those having received honorable mentions are automatically accepted into the 2012 show without pre-judging, however they still must submit their entrance fee of \$110 by March 23rd. The entrance fee entitles the applicant a booth space of eleven (11) feet for exhibition and sale of work. There will be a limit of ONE space for each applicant and the artist’s booth must contain only works in their prejudged category. Applicants are responsible for providing their own display racks and tables. No electric outlets will be available. The entrance fee also entitles the artist’s work to be judged in show day competition.

COMPETITION AND AWARDS

Art submitted for competition must be in the artist’s prejudged category. The awards are as follows:

Best of Show-\$600 First Place-\$500 Second Place-\$400 Third Place-\$300 Honorable Mention Awards-\$110

EXHIBITORS’ RESPONSIBILITIES

- Each artist is responsible for:
1. Setting up and dismantling display – following art show procedures
 2. Maintaining and staffing their booth
 3. All sales transactions
 4. Payment of all sales taxes

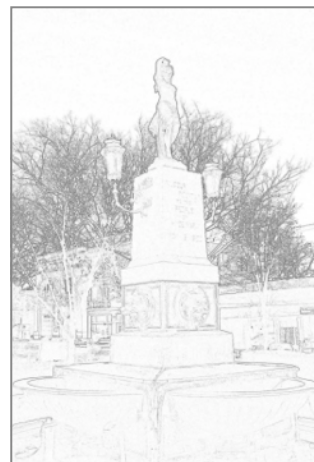
